Entre refus, critique plus ou moins violente, et obéissance aux usages et pratiques du siècle précédent, des attitudes variées s'observent, marqué es peut-être par des modalités différentes dans le discours, en fonction des disciplines scientifiques envisagées (astronomie, algébre, médecine, sciences de la nature). 8-9/05/2009, Glamorgan Research Centre for Literature, Arts and Science, The ATRiuM Campus, Cardiff, Phobia: Constructing the Phenomenology of Chronic Fear, 1789 to the Present

Keynote Speakers: Laura Otis (Emory University) and Andrew Thacker (De Montfort University)

The history of phobias as disease entities is intimately connected to the phenomenology of modernity. Whereas the emergence of spatial phobias such as agoraphobia (Carl Otto Westphal, 1871) and claustrophobia (Benjamin Ball, 1879) coincided with growing urbanisation and the development of the modern metropolis, Sigmund Freud's modern subject theory situated phobia at the heart of his psychoanalytical practice ('Little Hans', *Totem and Taboo*, *Inhibitions, Symptoms and Anxiety*). The fin de siècle was rife with cultural and social fears about the present and the future, and the twentieth century—with its two global conflicts, its natural disasters and the threat of terrorism—has ushered in a period of postmodern panic. Fear and anxiety are omnipresent in the modern age. But when, how and why does fear become chronic, morbid or abnormal? And in what ways has fear been conceptualised by medical practitioners, cultural theorists and artists?

This interdisciplinary conference looks at the different ways in which writers, artists, historians, art historians, cultural and human geographers, scientists and medical practitioners have constructed, represented and theorised phobia and chronic fear.

Proposals for papers on any aspect of phobias and anxiety disorders in the period from 1789 to the present are welcome. Interdisciplinary approaches are welcome as well. Topics may include but are not limited to: spatial phobias; biophobias; social phobias; phobia and the Gothic; the fin de siècle; phobia, modernisation and modernity; phobia and psychoanalysis; phobia and cultural geography; fear of science and technology; phobia, the senses and physical sensations; phobophobia.

A selection of conference papers will be published in a special ‘Phobia’ issue of *The Journal of Literature and Science*.

Communication from the Organizers: In 1989, the memorable XIIth congress was organized in Bergen. Exactly 20 years later, in 2009, we set out to repeat the success! With true gems of the history of medicine in our management, we hope to reach this goal. People from all over the world make pilgrimages to see the Bergen Leprosy Museum in St. Jørgens Hospital and the Bergen Leprosy Archives with the National Leprosy Registry of Norway (from 1856 onwards), in 2001 included on UNESCO’s list of Memory of the World. Eventually, Bergen has become a Mekka for scientists interested in registry based research. And they come to see Armauer Hansen’s Commemorative Rooms with his laboratory where he (in 1873) discovered the Leprosy bacillus.

In recent years, historians at the University of Bergen have set up a programme for research into the history of medicine with a number of young research fellows who will participate, presenting their

interesting projects. The first day of the Congress, on Wednesday 3 June, we will organize a Pre Congress Workshop on topics related to museums of the history of medicine addressing the challenge of how to select, preserve and present artifacts relevant to the rapid development in modern medicine. And we will organize a fascinating social programme including the old fortress Bergenhus with King Haakons grand hall from the mid 13th century as well as the fascinating archipelago surrounding Bergen.

Wednesday 3 June is the last night of The Bergen International Festival which means that you may extend your stay prior to the Congress to enjoy the delights of this significant cultural event (For info: www.fib.no). It also implies that hotel rooms in Bergen at this time may be scarce so don't postpone your registration for the Congress!

The 23rd Congress will be in Belfast in September 2009, Wed 2nd Sept to Sat 5th Sept. The Congress will be held at Stranmillis University College, a college of Queen's University Belfast. Stranmillis was founded in 1922 to provide state funded teacher training but now provides other courses and a conference centre. Hosts will be The Ulster Society for the History of Medicine (USHM) with the support and cooperation of the Centre for the History of Medicine in Ireland(CHOMI), medical historians at the University of Ulster, which is a partnership with University College Dublin. With this in mind, the conference, as well as encouraging presentations from other aspects of the history of medicine, will showcase work in Irish history of medicine. The staff at CHOMI will be participating and will present the results of their recent research to the conference. Those working on any aspects of Irish medical history are particularly encouraged to come forward with their suggestions for papers for 2009. The main themes of the conference will be: Irish medical history; Exploration and medicine overseas; Medical biography; Medical specialties; Epidemic diseases; Miscellaneous. There will also be a section devoted to students researching the history of medicine. Those with proposals for a paper should submit them, before 31st March 2009, in the form of an abstract of no more than 250 words outlining the main points and conclusions of the presentation with a few key references. Once your abstract is approved, you will be notified and participation in the Conference will then require the receipt of the completed registration form, and payment of the Conference fee. Please also submit a brief biography which will appear in the book of abstracts. As a record of the conference photographs will be taken of those who present papers. A form for printing or email submission is in Preliminary notice with call for abstracts (Word document). Please

send completed forms to: Professor Greta Jones, Centre for the History of Medicine, University of Ulster at Jordanstown, Shore Rd, Newtownabbey, County Antrim, Northern Ireland BT37 0QB. Abstracts can be submitted electronically to Professor Greta Jones at michael.liffey@ucd.ie. The residential accommodation is within walking distance of the Conference Centre, where the dining facilities are also located. There is plenty of on-site parking, again beside our Conference Centre, and which will be supervised by the SUC Security Staff. There is a security stop close to the SUC entrance, but the Conference Centre is still 400 metres inside the grounds. All accommodation, lecture rooms, and meals are on site. The Halls of Residence are centrally heated, double-glazed, and with kitchen/common rooms on each floor. Both single study bedrooms with wash-hand basins, and en-suite bedrooms, are available. SUC accommodation may also be used before and after the conference by our delegates. There will be an emphasis on Irish Medicine, on the contributions of some graduates of the Belfast Medical School, including some of the ‘Resuscitation Greats’. We also plan to have a Session specifically allocated to presentations by medical students who have participated in a Student Selected Component in the History of Medicine in a UK medical school. From Britain, Belfast is accessible by sea and air. P&O/Stena run daily services to Belfast / Larne from Troon, Cairnryan, and Stranraer. There are also ferries to Dublin from Holyhead & Liverpool, with travel to Belfast by train, car, or coach.

Scientific Excursions: The Austrian Society for the History of Pharmacy will organize guided tours to the Viennese highlights of history of pharmacy and medicine for congress participants and accompanying persons. You are kindly requested to register for these tours at the local registration desks. As the number of persons for each tour is limited, we shall list the participants according to the date of registering for the tours. Only tour 1 needs to be pre-booked, because it will take place before the beginning of the congress. Tour 1: Historical pharmacies in the city. Wednesday, September 16, 2009. Meeting point: University of Vienna, Main Building, Main Entrance. Duration: 14.00-16.00. Fee: € 10.00 per person.

We kindly ask you to book this tour when registering for the congress. The pre-booking will be based on the date of registration and the Congress Secretariat will send you a confirmation note. Due to the limited number of participants only persons who can show a confirmation of their pre-booking can take part in the tour in Vienna. The tour fee will be charged directly at the registration desk. In Vienna's first district, there are various pharmacies located in buildings of architectural interest or which show interesting historical furnishings. There are baroque-style pharmacies belonging to religious orders such as the Barmherzigen Brüder or the Ursulinen and pharmacies decorated according to Art Nouveau style, Classicism and Biedermeier. The former pharmacy of the Ursulinen order is now part of the collections of the Austrian Museum of Folk Life and Folk Art. When roaming around in Vienna's town centre your eyes will catch diverse details reminding of the town's history of pharmacy. They range from the memorial plaque of an apothecary attached to the facade of Saint Stephan's cathedral to a small shop specialised in selling antiquities of medical and pharmaceutical interest.

Tour 2: Historical collections of the Department of Pharmacognosy, University of Vienna. Saturday, September 19, 2009. Meeting point: in the entrance hall of the Lecture hall Centre (University Campus, Courtyard 2) after the closing of the congress. Duration: about 2 hours Fee: € 10.00 per person. If there is any further demand, additional excursions will be offered on Sunday, September 20, 2009, and during the following week. Meeting point: Sunday, September 20, 2009, and the following weekdays: Department of Pharmacognosy, University Vienna, Althanstraße 14, 1090 Vienna. Public transport: Underground: U4, U6, stop: Spittelau, exit Verkehrsampt. Tram: Line D, stop: Liechtenwerder Platz. Time and dates will be determined in agreement with the interested parties. The Department of Pharmacognosy houses representative collections of historical interest. The collection of pharmaceutical objects comprises many apothecary jars, instruments and pharmaceutical utensils and pharmacopoeias which mainly belonged to the former Imperial Pharmacy near the Emperors palace in Vienna. The second collection represents a comprehensive and valuable collection of medicinal drugs, whose origin dates back to the middle of the 19th century. Tour 3: Library of the Austrian Apothecary Association and Library of the Department of History of Medicine Thursday, September 17, 2009, and Friday, September 18, 2009. Meeting point: in the entrance hall of the Lecture hall Centre (University Campus, Courtyard 2). Duration: 16.00-18.00. Fee: € 10.00 per person. Near the Lecture hall Centre of the University Campus there are two important libraries regarding the history of pharmacy and the history of medicine. The small but well-assorted library of the Austrian Apothecary Association is located in a newly renovated Art Nouveau-style hall. The library contains not only countless valuable documents of Austrian apothecaries and acts of the former Hapsburg monarchy but also many pharmacopoeias, taxes, monographs and pharmaceutical journals. The library of the Department of the History of Medicine houses

a huge collection of historical medical books and is counted as one of the most important libraries in Europe. It even represents the largest specialist library in the German language area. The library was established under the reign of Emperor Joseph II to be used by the military physicians of the Medical-chirurgical Academy. Tour 4: Madhouse Tower - The Federal Pathologic-anatomical Museum Vienna Thursday, September 17, 2009, and Friday, September 18, 2009. Meeting point: in the entrance hall of the Lecture hall Centre (University Campus, Courtyard 2). Duration: 16.00-18.00. Fee: € 10.00 per person. The museum is open to the public (University Campus, entrance: van-Swieten-Gasse). For further details refer to www.narrenturm.at. The opening hours are: Wednesday (15.00-18.00), Thursday (8.00-11.00). The museum is located in a tower-like building which was erected in 1784. It was one of the first psychiatric hospitals and operated until 1866. Because of its shape and use it is still called the "Madhouse tower" by the Viennese. The museum was founded in 1796 as a museum of the Pathologic-Anatomical Institute. Today it houses the largest and oldest collection of such preparations worldwide. Most of the about 50.000 exhibits are maceration preparations (human and animal dry preparations of bones and other body parts with pathological changes), wet preparations (objects preserved in formaldehyde) and moulages (castings of pathological body parts in wax or paraffin). In addition, the collections include old and new medical devices illustrating specific diseases.

Tour 5: Museum of the History of Medicine, Medical University Vienna Thursday, September 17, 2009 and Friday, September 18, 2009. Meeting Point: in the entrance hall of the Lecture hall Centre (University Campus, Courtyard 2). Duration: 16.00-18.00. Fee: € 10.00 per person. The museum is open to the public (Josephinum, 1090 Vienna, Währingerstraße 25). The opening hours are Monday to Friday (09.00-15.00). The Department of the History of Medicine houses various medico-historical collections including a unique col-

lection of anatomical and obstetric wax models of the 18th century which was produced in Florence. When visiting the museum “Reale Museo di Fisica e Storia Naturale” (“La Specola”) in Florence, emperor Joseph II was fascinated by the exhibited lifelike wax models and ordered a duplicate collection for the future Medical-chirurgical Academy, Josephinum, in Vienna, After an arduous transport over the Alps the 1192 wax models finally reached Vienna. They were thought to illustrate the medical teachings at the Josephinum but also to be shown to the public. The wax models are displayed in the original show cases made of rose wood fitted with Venetian glass.

Tour 6: Austrian National Library - State Room and Collection of Manuscripts Thursday, September 17, 2009 Meeting point: in the entrance hall of the Lecture hall Centre (University Campus, Courtyard 2) Duration: 16.00-18.00 Fee: € 15.00 per person The State Room is open to the public (Österreichische Nationalbibliothek, entrance Josefsplatz). For further details refer to www.onb.ac.at. The opening hours are Tuesday to Sunday 10.00-18.00, Thursday until 21.00) The State Room designed in baroque style is one of the most beautiful historical library halls worldwide. Emperor Karl VI ordered the construction of this jewel of baroque architecture for his court library. It was built between 1723 and 1726 according to the plans of the renowned court architect Johann Bernhard Fischer von Erlach. The frescos of the ceiling were drawn by the artist Daniel Gran and finished in 1730. The collection of handwritten manuscripts is the nucleus of the library representing one of the most important collections worldwide. It includes numerous autographs and literary bequests and houses a jewel of history of pharmacy, the famous “Wiener Dioskurides”

SSHM Conferences: Since 1970, the Society for the Social History of Medicine has been actively involved in the organization of specialised conferences and has facilitated research and debate within the discipline of the social history of medicine, with a particular emphasis

However, membership of the Society entitles conference delegates not only to reduced registration fees (there are some bursaries available for student members on request) but also includes many other benefits, such as subscription to the journal *Social History of Medicine* and a 30% reduction on books published in the Society's Routledge series, *Studies in the Social History of Medicine*.
