Biographical notes

Bernardo Bernardi (born 1916), Professor of Ethnology at the University of Rome "La Sapienza", is honorary fellow of the Royal Anthropological Institute. He is also "membro onorario" of the Istituto Italo Africano. His known book The Mugwe. A failing prophet (1959) is now being published in Kenya under the new title The Mugwe. A blessing prophet. He has also published Age class systems. Social institutions and polities based on age (1985).

Cyril S. Belshaw, F.R.S.C. is Emeritus Professor in the University of British Columbia. He has written a number of field studies related to economic questions in Melanesia and an as yet unpublished comparison of the link between small comunities and federal government in Switzerland and Canada. His writings have also been concerned with the conceptual and theoretical issues that underlie anthropological statements. In addition he has explored the nature of applied anthropology and produced essays on its ethics, on thecnical assistance, on international communication, and on the nature of universities, among other themes. He has recently become interested in the anthropology of restaurants, and the hotel industry. He has been President of the International Union of Anthropological and Ethnological Sciences, Editor of Current Anthropology, and active in international interdisciplinary scholarly circles.

Daniela Borgogni (born 1949) took her degree in Literature with a thesis on the myths of Garo (Northeast India). She is in the Department of Archeological Sciences of the University of Pisa. She has published articles on her research in Sahelian economics and peasant culture in Tuscany.

David W. Brokensha, (D. Phil., Oxford University, 1963), is Professor of Anthropology and Environmental Studies at the University of California, Santa Barbara (CA), and also Director of the Institute for Development Anthropology. He has carried out research among farming peoples in Ghana (Larteh), Kenya (Mbeere), and California (Patterson). He has been an advisor and consultant to the World Bank, the Food and Agricultural Organisation of the United Nations, and the United States Agency for International Development. He is currently studying sociological aspects of transmission and control of AIDS in Africa. Recent publications include *The Mbeere in Kenya*, and several articles on inequality, rural development and social forestry.

Glynn Cochrane (Oxford, 1969) has special interests in social change, development anthropology, legal anthropology and institutional development in Third World countries. His work has taken him to Latin America, Africa, Asia and the South Pacific. His books include Development anthropology (1971), The cultural

appraisal of development projects (1979), and Reforming national institutions for economic development (1987). He was on the faculty of Syracuse University until 1984, when he left for a World Bank assignment as Advisor to the Government of Papua New Guinea to assist in public service reform.

Massimo Cresta (born 1928) has a degree in medicine and is Professor of Human Ecology at the University of Rome. He also teaches ecology and geography of nutrition in the School of Nutritional Sciences. He has done more than thirty years of fieldwork on the biology of human populations, especially relations between man and his environment in subsistence agriculture societies. He began studying conditions in southern Italy after World War II and has been involved for the last quarter century in problems of Western African countries.

Barbara Fiore, (born 1943) after graduating in anthropology at the University of Rome, dedicated herself chiefly to the study of relationships between social codes and symbolic systems (Arabe arabescate: note sul simbolismo dei tatuaggi maghrebini, "La Ricerca Folklorica" 4, 1981; La scrittura di Iblis. Note sulle iscrizioni tegumentarie del Maghreb, ibid. 5, 1982; Il velo di pietra, ibid. 11, 1985). She is the editor of a special issue of "La Ricerca Folklorica", devoted to the anthropology of space, the author of I nomadi, Loescher, Turin 1980, and the translator into Italian of a number of anthropological essays (Boas, Gluckmann, Kirk, Lloyd, Bateson among others). She has done fieldwork among the Ulad Asker of Tunisia, the Tuareg of the Air (Niger), the San Blas Cuna (Panama).

More recently, she has turned to applied anthropology, engaging in ethnomedical and ethnopsychological research: she is presently serving in the staff of the cooperation project for traditional medicine in Mali (Programme Medécine Traditionelle CRMTVèmeR – Bandiagara, Coopération Mali-Italie, INRSP – CNR [IP]) sponsored by the Italian Ministry of Foreign Affairs and by the Italian C.N.R., and has contributed to the collective volume Medécine traditionnelle, psychiatrie et psychologie en Afrique, Il pensiero scientifico, Rome

1988.

Peter C. W. Gutkind recently retired from McGill University, Montreal, where he had been Professor of Anthropology, 1963-1986. He has also taught at various African universities, was on the staff of the East African Institute for Social Research, 1953-1959, and also taught at the University of the West Indies. He is currently Professor and Visiting Overseas Research Fellow, Department of Sociology, University of Warwick, Coventry (U.K). He has published widely and only recently gave up his Senior Editorship of the Sage Publication Series on African Modernization and Development which resulted in 15 volumes. His main interests continue to be in urbanisation in the Third World, and the study of class and political consciousness of Third World workers. He is currently writing a history of the canoemen of southern Ghana.

Roberto Marchionatti (born 1950) is Professor of Economics at the University of Urbino and consultant to various economic institutions. He is the author of Il dibattito economico di oggi (1978), Rilevanza e limiti del neoricardismo (1981), Gli economisti e i selvaggi (1985) and many articles on the history of political economy and industrial organization.

Bruno Martinelli (born 1947) teaches at the University of Aix-Marseille I (Aixen-Provence Center), Department of Ethnology. He is doing field research on the dynamics of technology in sub-Saharan Africa. He is currently chargé de recherche with ORSTOM (Office de Recherche Scientifique et Technique Outre-Mer) and is doing field research in Burkina Faso and Togo on the evaluation of the processes of technological change. He is the author of numerous publications.

Mariano Pavanello (born 1944) is Professor of Ethnology at the University of Pisa. His major interests are economics anthropology and development anthropology. He has conducted field research in Italy on traditional handicrafts and in Africa on subsistence models in agriculture and pastoralism. His publications include several articles and books: L'incessante ricerca (1981), Antropologia ed economia dell'artigianato artistico (1983) and Le attività economiche fondamentali (1985).

Francesco Remotti (born 1943) is Professor of Cultural Anthropology at the University of Turin. He has written about general themes and issues in anthropological thought (Lévi-Strauss, Struttura e storia, 1971; I sistemi di parentela, 1973; La mente dei primitivi, 1974; Antenati e antagonisti, 1986). Since 1976 he has been doing fieldwork among the Wanande of Zaire. He has published several articles, most recently on questions of semantics. He also did an ethno-historical study of capital goods in Equatorial Africa and is currently working on a study of Italian society from an anthropological viewpoint.

† Harold K. Schneider (D. Phil., Northwestern University, 1953) was born in 1925 (Aberdeen, South Dakota, USA) and died on May 2, 1987, in Bloomington (IN). He taught Anthropology at Lawrence University from 1953 to 1970 and at Indiana University from 1970 to 1987. Professor Schneider received major grants to study the Pokot in Kenya, 1951-52, and the Turu in Tanzania in 1959-60. Associate Editor, American Ethnologist, 1980 to 1987. President (and founder) of the Society for Economic Anthropology, 1980-82. Elected Chairman, Board of Directors, Human Relation Area File, 1987. Professor Schneider wrote numerous articles, reviews and five books: Economic anthropology, The Wahi Wanyaturu, Economic man, Livestock and equality in East Africa and The Africans.
